

## ADOLESCENT DIRECTOR SEARCH CONTEST ELIGIBILITY REQUIREMENTS/TERMS AND CONDITIONS

Please note: the following eligibility requirements and terms must be met in order to proceed with the application process for ADOLESCENT CONTEST. Contest winners will be announced on November 22<sup>nd</sup>.

1. If selected you must be willing to sign the exclusive Adolescent Director's contract which gives Adolescent the right to represent you as a director for a length of 5 years.
2. You must be under the age of 25 years old.
3. You must submit video work that you directed.
4. You must be in excellent physical and mental health.

All submissions will be publicly displayed and you warrant that you have permission to assign the rights for displaying your work to us and our websites and social media platforms.

**TERMS OF SUBMISSION:** As conditions of entry into this contest, and by providing a submission, each entrant:

- Grants permission for winning videos and winners' names to be posted on the Adolescent website and in other Adolescent venues or media.
- Warrants and represents that her/his submission(s): (a) are original to the entrant and have been legally obtained and created, (b) do not infringe the intellectual property, privacy or publicity rights or any other legal or moral rights of any third party, or violate applicable laws, regulations, or network standards;
- Irrevocably grants to Adolescent, legal representatives, assigns, agents and licensees, the unconditional and perpetual right and permission to reproduce, encode, store, copy, transmit, publish, post, broadcast, display, adapt, exhibit and/or otherwise use or reuse the entrant's name, address, image, voice, likeness, statements, biographical material and submission, including, but not limited to, the video, audio file or digital recording and performances contained in any of the above items, as well as any additional photographic images, video images, portraits, interviews or other materials relating to the entrant and arising out of her/his participation in this contest (with or without using the entrant's name) (collectively, the "additional materials") in any media, without limitation, and without additional review, compensation, or approval from the Entrant or any other party.
